IABER srl does not acknowledge any documentation that has not been produced, issued, or distributed by itself or by its authorized representative.

This manual, as well as the entire technical file, will be kept by the manufacturer for the period prescribed by law.

During this period, a copy of the document may be requested at the time of sale.

The entire technical file shall remain available for that period, only to the supervisory authorities, who may request a copy. After this period, it will be the obligation and care of those who manage the product to ensure that both the product and the documentation observe the laws in force, in order to use it in accordance with the current legislation.

WARRANTY

The guarantee rules, which are listed in the purchase contract, are only valid if the PPE is used under the conditions of intended use. Any repair or modification made to the device by the user or unauthorized companies determines the forfeiture of the warranty. The warranty does not extend to damage caused by inexperience or negligence of use.

The products are covered in these following situations:

1. The warranty is valid for a period of twelve (12) or twenty-four (24) months depending on the legal nature of the purchaser.
2. The manufacturer is not responsible for damages caused by the use of the products at different from the intended use, only after a thorough check and detection of bad construction or use of the product.
3. The buyer always bears the responsibility of reporting faults in case of incorrect use of the product.
4. During the warranty period the replaced components become property of the manufacturer.
5. Only the original purchaser who has complied with the instructions of normal use contained in this guarantee. Our warranty liability expires when: the original owner hands over ownership of the device, or changes have been made to the device.
6. The warranty does not include damage resulting from excessive stress such as the use of the device after an anomaly has been detected, the use of inappropriate operating methods and failure to observe the instructions for use.
7. The manufacturer does not assume any responsibility for any difficulties that could arise in the resale or use abroad due to the current regulations in the country where the PPE was sold.

Disposable vinyl glove, non sterile and powder free.

The glove is unisex, ambidextrous, available in different sizes and packed in 100 pairs boxes each.

Application field and intended use:

The PPE is used to protect the hand from:

- mechanical superficial lesions;
- contact with less aggressive cleaning products or prolonged contact with water;
- contact with hot surfaces not exceeding 50 °C;

Unscheduled use

No use other than those described in paragraph "APPLICATION FIELD AND INTENDED USE" shall be used.

It is also absolutely forbidden:

- The use of gloves as a medical device.
- The use of PPE by people who have not read the manual carefully.
- Use by person allergic to the materials of which the product is made.
- Use by children in recreational activities.
- Applying gloves to injured skin or wound.
- Applying PPE to parts of the body other than the hands.

RESIDUAL RISKS

- It is absolutely forbidden to make any changes to the PPE. Any damage resulting from the use of the device, improperly modified by an unauthorized operator, relieves the manufacturer from any liability.

- Store the manual with care, it is necessary for a correct and safe use of the PPE.
- When the structure of the device is deformed by accidental impact, such as rubbing against an abrasive material, making the device dangerous and/or unusable, you need to contact authorized support and follow their directions or proceed to replace it with a new one.
- The PPE has a deadline and should NEVER be used if it is expired.

CONSERVATION

- Store the PPE in a cool environment, away from climate factors and steam jets
- Store the PPE away from heat sources, open flame and direct sunlight.
- Before storing the PPE ensure that the packaging of the item is intact and clean.

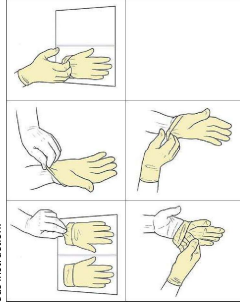
USE

Warnings:

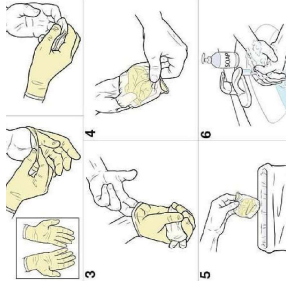
- Before using the protective device, check the glove to identify any possible flaws.
- Disposable glove.
- When properly worn, the glove should be comfortable, without any limitation of the movement of the hand.
- The glove can be worn continuously for up to 4 hours, thereafter it must be removed to let the skin breathe. It's possible to wear a new one after 10 minutes.

Use

1. Wash and dry your hands carefully before using the gloves
2. Place the gloves on a flat surface and turn the cuff slightly
3. Wear the first glove, grabbing it from the cuff
4. Wear the second glove following the previous instruction.



1. Remove the glove, ensure to not touch any uncovered body parts and flip over the inside with the outside.
2. Remove the second one following the instructions in figure 3 and 4
3. Dispose the product following the instructions on the manual
4. Wash your hands carefully with water and soap.



Disposal

After using the PPE, proceed with its disposal.

PPE construction materials do not require special disposal procedures. Follow the local regulations for the proper disposal

Do not disperse or abandon the product in the environment for any reason.
